1	<b><u>PRODUCT IDENTIFICATION AND INFORMATION</u></b> Product name: AMT Sulfate Reducing Bacteria Test Product code: AMT-I-B-002 Reagent Application Area: For detection of Sulfate reducing bacteria in liquid sample
2	<b><u>INFORMATION ON INGREDIENTS AND TOXICITY DATA</u></b> Chemical components (trade secret): Yeast extract: 0.1-5%; Magnesium sulfate: 0.1-5%; Sodium sulfate: 0.1-5%; Ferrous sulfate: 0.1-5%; Sodium thiosulfate: 10-40%; Calcium chloride: 0.1-5%; Ammonium chloride: 0.1-5%; Potassium phosphate monobasic: 0.1-5%; Sodium lactate: 10-40%; Methylene blue: 0.01-0.05%; Sodium chloride: 10-30%; Sea salt: 10-30%. Reagents are blended together in sterile condition. These media are then lyophilized to powder and sealed within the ampoule under vacuum environment. All the components are sterile. This sealed ampoule is packed in the box containing a thick sheet of paper insert, which protects the contents during storage and transport. STANDARD PACKING: One pack contains 30 ampoules. Each ampoule contains about 0.434 g reagent.

Wash the surface with water and dispose glass fragments

Empty vial can be reclaimed by simple washing with water and recycled or disposed as a non-dangerous material.</p> <p>Inoculated vials:  If the injected liquid contains toxic ingredients, follow instruction for the disposal of such substances.  Is advisable to neutralize bacteria growth eventually present in injected vials by thermal sterilization (autoclaving or one hour boiling) or by chemical sterilization (1 ml injection of bleach liquor).  If thermal sterilization is used is recommended to put the vials in thermal resistant bags to avoid liquid spreading through the pierced seal during the heating.</p>
